- i. CBE to complete the remainder of the outstanding work, less ongoing expenses, and the warranty deposit be retuned upon final acceptance of the work by Cowichan Bay Waterworks District after an additional warranty period; or
- ii. would CBE like CBWD to complete the work and return any remaining funds, less ongoing expenses, upon completion of the work and an additional warranty period?
- iii. that the Board does not consider the warranty period complete given the delays by CBE to start, let alone complete the work;
- iv. to advise the Board of their choice.
