2025 AGM Talking Points – Operations

Upgrades

- Telegraph Reservoir interior hardware replaced, leaks repaired, and reservoir cleaned
- New PLC (program logic control) and control panel at Valleyview pump station heartbeat of the system
- Kiosks put over Valleyview wells for protection and rocks to prevent people from driving on the field
- Old office concrete reservoir disconnected from system

Operations Staff

 Both operators advanced in the EOCP training program getting their operator in training and Operator 1 certificate.

Maintenance

- Fire Hydrants maintenance ongoing
- All three reservoirs' interiors were inspected
- Watermain Flushing completed
- Backflow Testing completed
- PRV and altitude valve monitoring

System

- Great source at Valleyview, water samples are taken weekly and sent to Island Health.
- Chlorine residual above .2 mg/L maintained throughout the system. This is to prevent bugs from growing in the system
- Turbidity readings stayed low
- We had two watermain breaks. One on Pritchard due to an old repair clamp and the other in the village on Cowichan Bay rd. This was a cracked AC watermain.
- We had one major service leak on Wessex
- Asbestos testing was completed with a negative result. Samples were done on George and Glen.
- Crew responded to many leaks on homeowner side where we would set up jumper systems to keep them in water while they found someone to repair them
